1. **Palatine High School** will take the following actions to involve parents in the joint development of its school parental involvement plan under section 1118 of the ESEA:
 - *Hold semi-annual meetings with school Title 1 personnel available to facilitate parent communication and involvement.*
 - *A school social worker will be employed to facilitate the communication between the schools and Title 1 parents.*
 - *Use of e-mail, phone and web site contacts*
 - *School District 211 will provide access to a district Title 1 coordinator.*

2. **Palatine High School** will take the following actions to involve parents in the process of school review and improvement under section 1116 of the ESEA:
 - *Hold semi-annual meetings with school Title 1 personnel available to facilitate parent communication and involvement.*
 - *A school social worker will be employed to facilitate the communication between the schools and Title 1 parents.*
 - *Use of e-mail, phone and web site contacts*
 - *School District 211 will provide access to a district Title 1 coordinator.*
 - *Will provide on-line access to the school improvement plan (SIP)*

3. **Palatine High School** will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs, and to explain the Title I, Part A requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:
 - *Reviewing and distributing the district parental involvement policy.*

 - *Making a written and on-line version of the school curriculum guide available.*
 - *Presentations at the annual open houses.*

 - *Holding bi-annual parent meetings*

- *Critical Learning Standards in Math and Reading will be posted on the school web-site and made available in hard copy.*
 - *Providing written and on-line reports of student scores on standardized or nationally normed assessments, including but not limited to, EXPLORE, PLAN, ACT, and MAP tests.*
5. **Palatine High School** will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:
- *Holding bi-annual parent meetings.*
 - *Holding parent conferences in person, by phone or e-mail when appropriate.*
 - *Incorporating suggestions into the parent compact.*
6. **Palatine High School** will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
- *Providing written report cards and mid-term notices*
 - *Providing score reports from a variety of normative assessment measures such as MAP, EXPLORE, PLAN and ACT.*
 - *Provided access to student grades through our on-line parent access portal*
7. **Palatine High School** will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:
- *Personal contact will be made by a school representative, however all Teachers and Teacher Assistants are highly qualified and will remain so in the future.*
8. **Palatine High School** will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
- *Providing computers and training at the Palatine Opportunity Center*
 - *Providing training on the mechanics of using the parent access portal at open house.*
 - *Continuing education courses.*
9. The **Palatine High School** will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
- *All communications will be sent in multiple languages and formats.*
